

**SUBJECT:** Adopted Sarcoidosis Rules Approved By To LCAR On January 30, 2008

Attached please find the final adopted sarcoidosis rules. These rules were considered by LCAR on January 23, 2008 and approved by LCAR on January 30, 2008. In response to issues raised by the Committee at the first hearing, the definition of the term "sarcoidosis" was changed. Various typographical and grammatical errors were also corrected.

**Summary of the Substantive Change:**

The definition of "sarcoidosis was changed from a more formal medical definition to the following:

"Sarcoidosis" – the proper diagnosis of sarcoidosis requires the exercise of professional medical judgment in accord with accepted medical practices. If disputes arise over the diagnosis, claims shall be evaluated on an individual basis.

Both The State of Vermont Risk Management Division and the VSEA testified that this definition was sufficient and the Committee approved the change.

These new rules will be effective Monday February 18, 2008.
