Effective with the filing of the report due on May 1, 2023, for the quarter ending March 31, 2023, the taxable wage base is \$13,500.

# **Wage and Hour Updates**

Effective January 1, 2023, Vermont's minimum wage will increase from \$12.55 to \$13.18 per hour. The basic wage for tipped employees will increase to \$6.59 per hour. Service or tipped employees are employees who customarily and regularly receive more than \$120.00 a month in tips for direct and personal services.
