Subject: Unemployment Insurance Weekly Update

Executive Summary:

For the benefit week ending March 20, there were 33,788 weekly claims filed. This is a decrease of 953 over the previous week, the benefit week ending March 13, where 34,741 weekly claims filed. Even with a decrease in claims filed, this is still significantly higher than pre-pandemic conditions. For the week ending March 20, \$13,236,291 in benefits were paid out to claimants.

On March 26, the Department released data on the Vermont economy for the month of February 2021. According to the household data, the seasonally adjusted statewide unemployment rate for February was 3.1 percent. This reflects a decrease of one-tenth of one percentage point from the prior month's revised estimate of 3.2 percent.

We are currently seeing a large number of claimants approach the one-year anniversary of submitting their initial unemployment application. When an initial application is submitted, the over-arching claim remains active for 12-months. When the 12-months expires, the benefit year expires as well, and claimants must open a new benefit year to continue to file weekly claims. This can be done by logging into the online claimant portal and only applies to individuals filing in the regular UI system, not Pandemic Unemployment Assistance (PUA). Claimants who are identified as approaching the end of their benefit year will receive an email from the Department reminding them of the necessary steps so they may continue to file without disruption.

The Department continues to review program guidance related to the implementation and administration of the unemployment programs extended in the American Rescue Plan Act. At this time, program extensions have been granted until the benefit week ending September 4, 2021. This includes Pandemic Unemployment Assistance, Pandemic Emergency Unemployment Compensation and Federal Pandemic Unemployment Compensation.










